The aim of the double degree programme Master in Business Administration is to provide the candidates of the Bologna-based +2 study with an in-depth knowledge and skills related to the business fields. This programme prepares students for various and changing managerial and expert functions. The programme offers students the opportunity to specialize in the issues which best respond to the needs of working life and their own particular interests. Master's studies include two options: Specialization in Bank and financial management or Specialization in Accounting.

For applicants that have a BA diploma in social and business sciences and in environmental sciences there are no prerequisites. For applicants with BA diploma in other sciences there are two prerequisites (courses) that should be passed before or after the enrolment - Introduction to Business and Microeconomics 1.

The aim of the master's study in Islamic banking is to acquire additional knowledge in the field of Islamic banking and finance. The study is practice-oriented and intended for managers of all levels in the banking sector, banking professionals, and students who have completed the undergraduate programs and see their business future in the banking sector, especially in the field of Islamic banking, as the fastest-growing segment of the banking industry.

TARGET GROUPS

Studies are adjusted for people who work – every month students attend lectures and take the exam in one course. Lectures are organized within one week, outside working hours. Rest of that month students are free to prepare assignments and study for exam, so they don't have to be in Sarajevo during that time.
