1. BIOGRAFSKI PODACI

Eldin Mehić je rođen 31. januara 1974. godine u Zenici. Osnovnu školu završio je u Žepču, a srednju Matematičko-fizičko-računarsku školu u Zavidovićima. Ekonomski fakultet u Sarajevu upisao je školske 1995/96. godine, a diplomirao u julu 1998. godine. Postdiplomski studij kandidat je takođe završio na Ekonomskom fakultetu u Sarajevu (u daljem tekstu: EFSA) i stekao titulu magistra ekonomskih nauka 21. marta 2005. godine odbranom magistarskog rada pod naslovom „Uticaj tehnološkog razvoja na dokumentarni akreditiv“. Doktorsku disertaciju na temu „Determinante i efekti stranih direktnih investicija u zemljama Jugoistočne Evrope“ uspješno je odbranio 26. augusta 2010. godine na Ekonomskom fakultetu Univerziteta u Sarajevu i time stekao titulu doktora ekonomskih nauka.

U periodu od septembra 1998. do aprila 1999. godine radio je u Srednjoj mješovitoj školi u Žepču, kao profesor ekonomske grupe predmeta. U aprilu 1999. zasnovao je radni odnos u Šipad export importu kao komercijalista u izvoznom sektoru. U oktobru 2000. godine prelazi u Petrol bh oil company, gdje radi na poslovima uvoza nafte i naftnih derivata. Od 2001. zaposlen je kao asistent na Ekonomskom fakultetu u Sarajevu. U 2005. godini izabran je u zvanje višeg asistenta na oblast Ekonomске teorije i politike. Nakon odbrane doktorske disertacije izabran je za docenta na Ekonomskom fakultetu a u 2016. godini izabran je za vanrednog profesora na EFSA. U dosadašnjem radu na Fakultetu bio je angažovan na brojnim predmetima: Tehnološki razvoj i ekologija, Transnacionalne korporacije, Svjetski ekonomski razvoj, Ekologija i ekonomski razvoj, Analiza vanjske trgovine, Aktuelna pitanja svjetske ekonomije, Ekonomija tranzicije, Ekonomija okoliša, Marketing usluga, Međunarodna ekonomija, Spoljnotrgovinsko poslovanje, Globalna ekonomija, Ekonomija okoliša itd.

Pored angažmana u nastavnom procesu, dr Eldin Mehić je od 2018. godine prodekan za nastavu i međunarodnu sasradnju. Angažovan je na brojnim projektima na Fakultetu između kojih izdavajamo članstvo u timu za akreditaciju AACSB i EPAS, web redakciji, organizacijskim odborima međunarodnih konferencija ICES-a i Ekonomskog foruma. Voditelj je i I ciklus studija „Business studies“ u saradnji sa Griffith College Dublin te master programa Javni sektor i okoliš i MBA koji se realizuje u saradnji sa Ekonomskim fakultetom u Ljubljani. Pored navedenog, angažovan je kao ekspert i istraživač u više projekata.

U svom dosadašnjem radu Kandidat je objavio veliki broj naučnih radova koji su objavljeni u indeksiranim časopisima, časopisima sa priznatom recenzijom i referentnim zbornicima. 4. NASTAVNO–PEDAGOŠKI RAD

U dosadašnjem radu na Fakultetu bio je angažovan kao asistent, viši asistent i docent na predmetima: Tehnološki razvoj i ekologija, Međunarodna ekonomija, Transnacionalne korporacije, Svjetski ekonomski razvoj, Ekologija i ekonomski razvoj, Analiza vanjske trgovine, Aktuelna pitanja svjetske ekonomije, Ekonomija tranzicije, Ekonomija okoliša, Marketing usluga, Spoljnotrgovinsko poslovanje itd. U statusu vanrednog profesora, kandidat je izvodio nastavu na predmetima Globalna ekonomija, Ekonomija okoliša, Vanjskotrgovinsko poslovanje, Ekonomija i upravljanje okolišem, Globalna ekonomija: odabrane teme na različitim stepenima studija. Pored toga, angažovan je kao nosilac predmeta Institucije globalne ekonomije na Fakultetu političkih nauka, Univerziteta u Sarajevu. Navedeni angažman je kandidatu omogućio da proširi naučna znanja i istraživački rad iz oblasti Međunarodne ekonomije i razvoja.

Kandidat je u svom radu stekao zavidno iskustvo u pedagoškom radu sa studentima, a u zvanju vanrednog profesora uspješno je okončao mentorstvo na 12 završnih radova II ciklusa studija i bio član brojnih komisija za odbranu završnih radova.

U kontekstu nastavno-pedagoškog rada Komisija posebno ističe angažman Kandidata u kreiranju i unapređenju nastavnog plana i programa Ekonomskog fakulteta za period 2021-2026. godina te kreiranju nastavnih planova za studij Business studies i MBA koji se realizuju sa ino partnerima.

5. MIŠLJENJE I PRIJEDLOG KOMISIJE

Na osnovu detaljnog uvida u dostavljenu dokumentaciju o biografiji, naučno-istraživačkom i stručnom radu, dodatnoj profesionalnoj edukaciji, te nastavno-pedagoškoj aktivnosti Mehić dr Eldina, a u kontekstu nephodnih kriterija za izbor u zvanje redovni profesor, Komisija konstatiše da je dr Eldin Mehić ispunio sve uslove za izbor nastavnika u zvanje redovni profesor, kako slijedi: proveo je jedan izborni period u zvanju vanrednog profesora, objavio je najmanje dvije objavljene knjige i najmanje osam naučnih radova iz oblasti Međunarodna ekonomija i razvoj u priznatim publikacijama koje se nalaze u relevantnim naučnim bazama podataka te je uspješno završio mentorstvo najmanje jednom kandidatu za stepen drugog ciklusa studija. U kontekstu uslova za izbor koji se odnosi na uspješno završeno mentorstvo najmanje jednom kandidatu za stepen trećeg ciklusa studija, Komisija je izvršila ekvivalenciju navedenog uslova sa uspješnim vođenjem međunarodnog projekta od značaja za Ekonomski fakultet u skladu sa članom 199. Statuta Univerziteta u Sarajevu. Komisija u kontekstu uslova za izbor kandidata u zvanje redovni profesor ističe da je dr Eldin Mehić objavio i više naučnih radova (u odnosu na minimalne uslove utvrđene Zakonom i Statutom) u priznatim publikacijama koje se nalaze u relevantnim naučnim bazama podataka uključujući i citatne baze Web of science i Scopus te da je za ekvivalenciju upješnog mentorstva na trećem ciklusu studija imao pored uspješnog vođenja projekata od značaja za EFSA i tri dodatna naučna rada objavljena u relevantnim bazama podataka u odnosu na minimalne uslove utvrđene Zakonom i Statutom.

Svoj nastavni, naučno-istraživački i pedagoški rad dr Eldin Mehić je uspješno obavljao na sva tri ciklusa visokoškolskog obrazovanja kroz veći broj predmeta iz oblasti Međunarodna ekonomija i razvoj te kroz rad kao Prodekan za nastavu i međunarodnu saradnju EFSA. Također, Komisija ističe da Kandidat ima veoma bogato iskustvo u nastavno-pedagoškom radu koje traje 20 godina.

U kontekstu istraživačkog rada, Komisija konstatiše da se specifično iskustvo Kandidata odnosi na istraživanja o tranzicijskim problemima prvenstveno sa naglaskom na zemljama Centralne i Istočne Evrope i Jugoistočne Europe, uključujući pitanja ekonomskog rasta i konvergencije, industrijskog restrukturiranja i konkurentnosti, stranih direktnih investicija, te okolinske politike. Sagledavanjem obuhvata i metodologije publikovanih naučnih istraživanja Kandidata, Komisija konstatiše da Kandidat posjeduje znanja iz oblasti međunarodne i primijenjene ekonomije, te posebno naglašava primjenu različitih ekonometrijskih metoda i tehniku u člancima i studijama objavljenim u referentnim časopisima i od strane referentnih institucija.


