Under ERASMUS+ programme

#### A. General Information

*School of Economics and Business Sarajevo*, University of Sarajevo, has signed inter-institutional agreement with *Wirtschaftsuniversität Wien* based on KA-107 ERASMUS+ programme. We are proud to open application call for **1 teaching staff** for winter semester at prestigious University in Austria, *Wirtschaftsuniversität Wien* (<https://www.wu.ac.at/>).

Number of open places for the mobility is specified as following:

**One (1) grant for Staff Mobility for Teaching - 5 days**

Teaching staff can apply for mobility for the purpose of teaching (in English) and Training.

**Application Deadline: April, 25<sup>th</sup> 2018**

Mobility must be organized and carried out solely for the period from 1 October 2018 to 15 January 2019. The mobility of staff for the purpose of teaching lasts **5 days** (excluding days spent on the road) and the requirement is to maintain a minimum of 8 hours of lectures.

#### B. Application Requirements

Candidates must meet following requirements:

1. They must be member of teaching staff at School of Economics and Business, University of Sarajevo, full time employees at SEBS (Professors, Assoc. Professors and Ass. Professors, as well as Teaching assistants).
2. They need to have Dean's approval of the absence of candidate from workplace.
3. They need to have excellent knowledge of foreign language in which classes are held.

#### C. Selection Criteria

1. Correctly filled application form and properly delivered application documentation;
2. Quality and content of curriculum (length of stay in accordance with the scope of activities that are going to be carried out, the method of dissemination of experiences upon returning to the SEBS, the benefits for further work at home institution);
3. Knowledge of language for professional training or the language in which classes are held;
4. Additional Engagement at School;
5. Advantage would be given to applicants who did not use ERASMUS+ programme in the past.

**Incomplete and late applications will not be taken into consideration.**

#### **E. Application Documentation:**

##### **REQUIRED DOCUMENTS:**

- Application form (Syllabi for Teaching/ Syllabi for Training);
- CV (Europass form) in English language;
- Staff Mobility Agreement filled and signed by home and host HEI;
- Signed and verified Dean's approval of the absence of candidate from the workplace for agreed period.

#### **F. Selection Process**

The election procedure is carried out in three main steps at SEBS:

Step 1 – administrative check of applications

Step 2 – evaluation of curriculum

Step 3 – the selection of candidates for mobility by the Selection Committee (consisted of Vice-Dean for Academic Affairs and International Cooperation, Head of Staff Development Center and Head of International Office).

University has the right to reject application if there is no possibility of providing terms for classes of the above areas. In this case, the University will submit the first following candidate from the list.

**Deadline for application at Wroclaw University of Economics is 1<sup>st</sup> May 2018**

#### **G Announcement of application results**

Final results of the Application Call will be communicated to all candidates through e-mail. By entering the competition, candidates agree to have their name published on the list of selected/rejected candidates or on the waiting list.

#### **H. Financial support**

For the calculation of financial support for each person following costs are taken into account: cost of living (for working days spent on mobility including 2 days spent on the road) and travel expenses defined by the European Commission. Candidates cannot be financed within Erasmus program if their stay abroad is going to be supported from the funds coming from the European Union.

#### **I. Other**

Chosen candidates are required to follow prescribed procedures before and after their return from international institution, as well to submit requested documentation to School of Economics and Business and SEBS International Office.

<b>Distance</b>	<b>Amount*</b>
<b>between 100 and 499 km:</b>	180 € per participant
<b>between 500 and 1999 km:</b>	275 € per participant
<b>between 2000 and 2999 km:</b>	360 € per participant
<b>between 3000 and 3999 km:</b>	530 € per participant
<b>between 4000 and 7999 km:</b>	820 € per participant
<b>8000 km and more:</b>	1.100 € per participant

\*Amount covers travel costs according to the venue of activities.
