# Ethical guidelines for journal publication

Journal of Forensic Accounting Profession (The Journal) is published by the School of Economics and Business in Sarajevo (The Publisher). The scientific and professional papers, relating to forensic accounting, including topics of financial investigations, forensic audits, financial expertise, as well as other forensic accounting services in the function of court support, as well as works of multidisciplinary approach in the field of economics, law, criminology, sociology and psychology that ultimately contribute to combating fraud are accepted for publishing.

To ensure the high quality of the journal, the publisher has established guidelines based on and aligned with Committee of Publication Ethics' (COPE) Guidelines on good publication practice. Following guidelines apply to publisher, editors, authors, reviewers and other parties involved in publishing of the Journal.

### **AUTHORS & AUTHORS RESPONSIBILITIES**

By submitting papers for publication in the Journal authors agrees to the following:

- Submitted paper is result of the original work of the one or more persons designated as authors and authorship includes only those persons who have significantly contributed to the research.
- Submitted paper or its parts hasn't been previously published in other publications.
- Research presented in paper is based on real, accurate and verifiable data. Authors are required to provide explanations and information on the research data, data-sets or raw data and its source upon the request of the editor.
- Honor the copyright of the used resources in a manner of proper acknowledgement of literature and obtaining permission for content such as images, graphs, data sets etc.
- There is no conflict of interest which would violate general principles of objective scientific research. Authors are invited to provide all information on the funding sources of their research
- By submitting the paper, authors agree to plagiarism check by corresponding software.
- Submitted paper should be composed and formatted in accordance with the Instructions for Authors.
- Submitted paper is the subject to the double blind peer-review process.
- Author(s) agree to transfer all rights in and to the Work, including copyright and those pertaining to electronic transmission and delivery, exclusively to **Journal of Forensic Accounting Profession** (the "Publisher") on a worldwide basis in all languages upon
- acceptance of the Work for publication within the Journal. The Publisher agrees that all rights shall revert to the Author(s) if the Work is not published.

Authors are required to cooperate with the editors in peer-review process and provide corrections of errors or inaccuracy or provide counter-argument to reviewers' comments if needed.

The Journal will not charge any fees to the authors for proceeding, reviewing, storing, printing or any other actions concerning the publishing procedure of the submitted papers.

#### PEER-REVIEW PROCESS & REVIEWER RESPONSIBILITIES

- All submitted papers should be written in compliance with the Author Guidelines in the manner of language, composition, form and citation rules. If submitted paper does not comply with the aforementioned instructions, editors will propose the corrections and improvements to the author.
- All submitted papers are subject to the double blinded peer-review. Author's data would be removed before sending the paper to peer-reviewers in order to obtain the opinion on the individual paper from the independent expert in the field. The papers with the positive peer-review will be published and classified either as original scientific paper, preliminary communication, review article or professional paper.
- The Journal will ensure to engage experts in the specific field covered by the submitted paper for its peer-review.
- The peer-reviewers shall fulfill the task objectively and indifferently and solely based on professional, scientific and ethical standards. Peer-reviewers are obliged to maintain confidentiality of any data or findings expressed in the paper. Peer-reviewers are obliged to point out any possible conflict of interest before accepting the task and retreat from the peer-review procedure.
- In the case of discrepancies in two independent peer-reviews the editor withholds the right to make a final decision on publishing of the paper if appropriate or to engage third independent peer-reviewer. In such cases editor will fulfill the task objectively and indifferently and solely based on professional, scientific and ethical standards. All the aforementioned responsibilities of the peer-reviewer shall apply to the Editor.
- Peer-review shall be done in accordance with the guidelines for the reviewers, classification guidelines and should be submitted by the paper review form.
- Authors are entitled to the fulfilled peer-review form of their paper. Editor will ensure that the peer-reviewer personal data is undisclosed.

# PUBLISHER & EDITORS ETHICS & RESPONSIBILITIES

Publisher and Editors shall ensure the following:

- The equal publication procedure for each submitted paper that meets the Journal's standards. They shall fulfill their task objectively and indifferently and solely based on professional, scientific and ethical standards, sustaining from any discriminatory actions against the authors on grounds of gender, sexual orientation, religious or political commitments, ethnics or geographical origins or nationality.
- Assessment of the submitted papers is based exclusively on the objective criteria and in accordance with the basic standards and rules of the profession.
- All reasonable activities to identify and prevent the publication of papers where plagiarism or any other form of scientific misconduct or malpractice has occurred, including the use

- of anti-plagiarism software, engagement of the recognized experts in the field as reviewers, proceeding the malpractice complaints from the third parties.
- To sustain of encouraging scientific misconduct or malpractice or to intentionally allow such misconduct or malpractice to take place.
- If appropriate publish the corrections, clarifications, retractions and apologies.
- The rejected and unpublished papers won't be misused by editors or publisher in any circumstances.

All activities and decisions of the editor in chief, editorial board, technical editor and other technical staff shall be based exclusively on objective scientific, academic and technical standards. Publisher and Journal's partners shall sustain from any influence regarding the content of the Journal for any commercial or political reasons.
