





The contract will be awarded to the tenderer that submitted an administratively and technically compliant tender with and offered the best value for money. Technical offer will be considered with the weight of 80% and financial offer will be considered with the weight of 20% during the evaluation./ *Ugovor će biti dodjeljen onom ponuđaču koji je podnio administrativno i tehnički ispravnu tendersku ponudu i koja nudi najbolji odnos cijene i kvaliteta.
